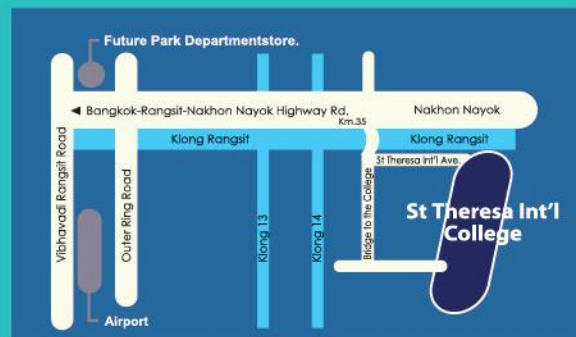
Admission Requirements
